Roles Included: Field Educator, Site Manager, Ed Support and WildLink Staff

As a Field Educator for NatureBridge my duties included educating and guiding students of various ages in Yosemite National Park. Students received educational programming including coursework in Geology, Ecology, and Cultural History. In addition team building and self-challenge was emphasized with the hope of fostering a sense of self-reliance and community with fellow students. Seasonal differences brought different duties and along with academic learning my duties included teaching cross-country skiing, snowshoeing, leading backpacking trips (all seasons), teaching LNT ethics and various other outdoor living skills. Additionally my duties included facilitating campfire programs and also an evening program based on transferable environmental messages. My accomplishments included gaining a greater comfort in the mountain environment both with students and solo, acquiring new outdoor recreation skills and gaining a better appreciation and understanding of the Sierra Nevada environment and its connection to the larger natural world.

As a Site Manager at the Crane Flat campus my duties were more centered on program logistics. In addition I was a liaison between NatureBridge and our participants and their first contact person when they arrived to Yosemite. Logistical duties centered around maintaining a safe and efficient residential outdoor education campus and ensuring that participants were having their needs met while off trail. In addition I ensured their success on trail through careful preparation and expectation setting prior to meeting their instructors. I also was in charge of running meals and basic maintenance duties. My NatureBridge liaison duties were focused on welcoming participants and adult chaperones to Yosemite and explaining procedures for both campus and trail. In addition, I ran adult chaperone meetings in which I covered basic program orientation, expectations, duties and alleviated medical, emotional or physical concerns with all participants.

As a member of the Education Support team I worked in the office for one week a month. During this time I was asked to fulfill many duties. The first was a project where I created connections between NatureBridge and stewardship organizations in California. I created content for our website that allows participants to find opportunities for stewardship in their home communities. In addition I was expected to assist in office duties that ranged from answering phones, assisting educators in the field, ensuring proper arrival and departure time with bus companies and acting as Day Manager.

As a WildLink Educator I operated in both the front and backcountry. While in the front country I met with participants and fulfilled the duties mentioned above in my Field Educator role. In addition, I had the opportunity to interact with more diverse populations and work on developing culturally relevant materials. The backcountry portion of my WildLink role enabled me to share the backcountry with participants who might not normally be afforded these opportunities. Many of the duties were similar to those mentioned above as a field science educator in the backcountry. However I also learned skills necessary for working with various behavioral and emotional issues not normally encountered with other NatureBridge programs.
